Privacy Policy

This Privacy Policy outlines how Biz Elevate Funding (“Biz Elevate Funding,” “Company,” “Us,” “We”) collects, uses, maintains, and discloses information from users (each, a “User”) of the bizelevatefunding.com website (the “Site”). This privacy policy applies to the Site and all products and services offered by Biz Elevate Funding.

California Privacy Rights

If you are a resident of California, the California Consumer Privacy Act of 2018 (“CCPA”) grants you certain rights regarding the personal information you have shared with us through your use of our Services. Under the CCPA, you have the right to know what personal information is collected, used, shared, or sold; the right to delete your personal information; the right to opt out of the sale of your personal information; and the right to be free from discrimination regarding price or service when exercising your rights under this Act. Biz Elevate Funding collects and uses User information consistently, as outlined below. Please see the Opt-Out Choices section below.

Personal Identification Information

Biz Elevate Funding may collect personal identification information from Users in various ways, including but not limited to:

- When Users visit our Site or use mobile applications.
- Registering on the Site.
- Completing any forms on our website.
- Interacting with our emails or text messages.
- Visiting any page displaying our ads or content.
- Engaging with our blogs, social media, or affiliated sites.
- Call us directly or provide information via phone, email, text, or facsimile.
- Interacting with our advertising and applications on third-party sites when those advertisements link to this policy.

Users may be prompted to provide their name, email address, mailing address, and phone number. However, Users can visit our Site anonymously. We collect personal identification information only if it is voluntarily submitted. Users can refuse to provide this information, although it may limit their ability to engage in certain activities on our Site.

Non-Personal Identification Information

Biz Elevate Funding may also collect non-personal identification information about Users whenever they interact with our Site. This information may include the browser name, the type of device used, and technical information about Users' means of connection to our Site (e.g., the operating system, Internet service providers, etc.). This information is used to better understand how users engage with the Site and improve our services.

Web Browser Cookies

Our Site may use "cookies" to enhance User experience. A User's web browser places cookies on their hard drive for record-keeping and sometimes to track information about them. Users may set their web browser to refuse cookies or alert them when cookies are sent. If they do so, some parts of the Site may not function properly. Note that cookies may be connected to personal information.

How We Use Collected Information

Biz Elevate Funding may collect and use Users' personal information for the following purposes:

- **To Improve Customer Service:** Your information helps us respond more effectively to customer service requests and support needs.
- **To Personalize User Experience:** We may use aggregated information to understand how Users use our services and resources on the Site.
- **To Improve Our Site:** We may utilize feedback provided by Users to enhance our offerings.
- **To Share with Third Parties:** We may share or sell information for marketing or other purposes.
- **To Send Periodic Emails:** We may use the email address to send User information and updates regarding their order. If Users opt into our mailing list, they will receive emails that may include company news, updates, and related product information. Instructions on how to unsubscribe will be provided in each email.
- **To Send Updates About Your Business Cash Advance:** We may use Users' mobile numbers to contact them via text message regarding offers or updates. By providing your mobile number, you consent to receive these messages. Msg. and data rates may apply. To opt-out, text STOP to the designated number.

Users may encounter advertisements or other content on our Site that link to the sites and services of our partners and third parties. We do not control the content or links of these websites and are not
